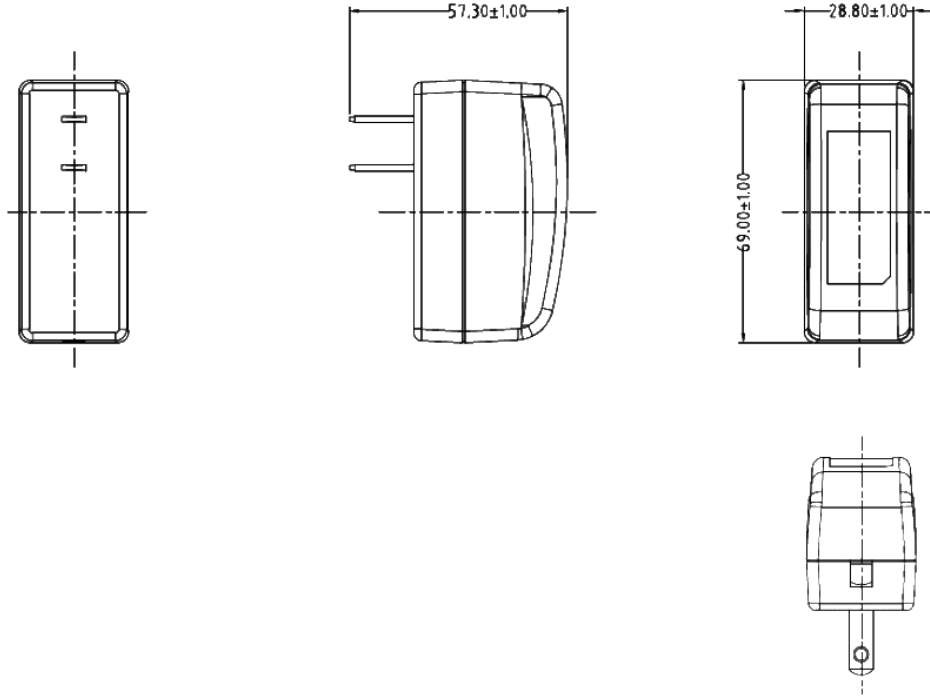

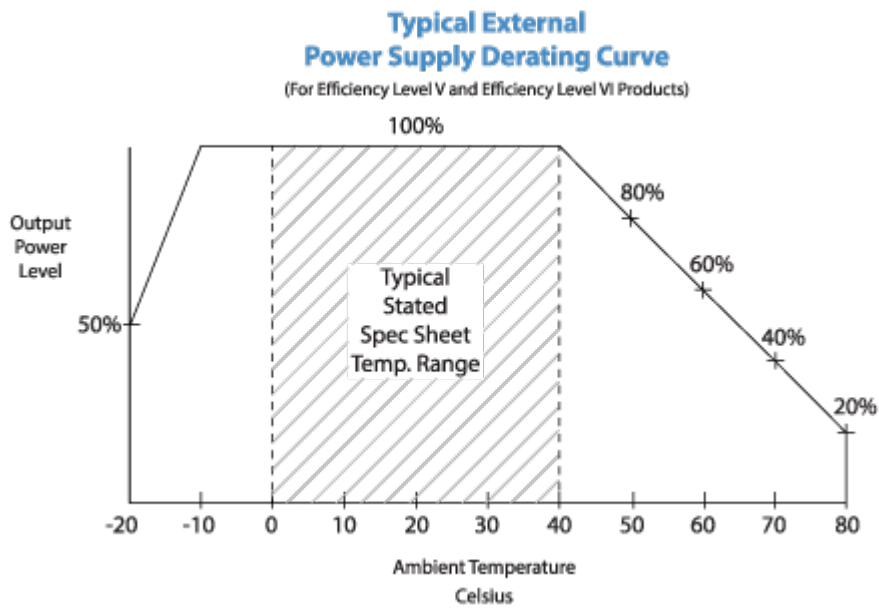

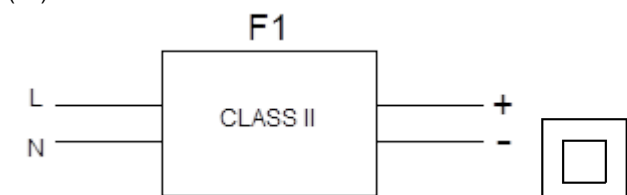
DERATING CURVE

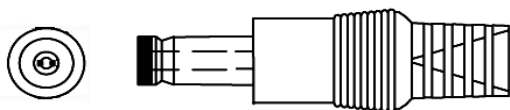

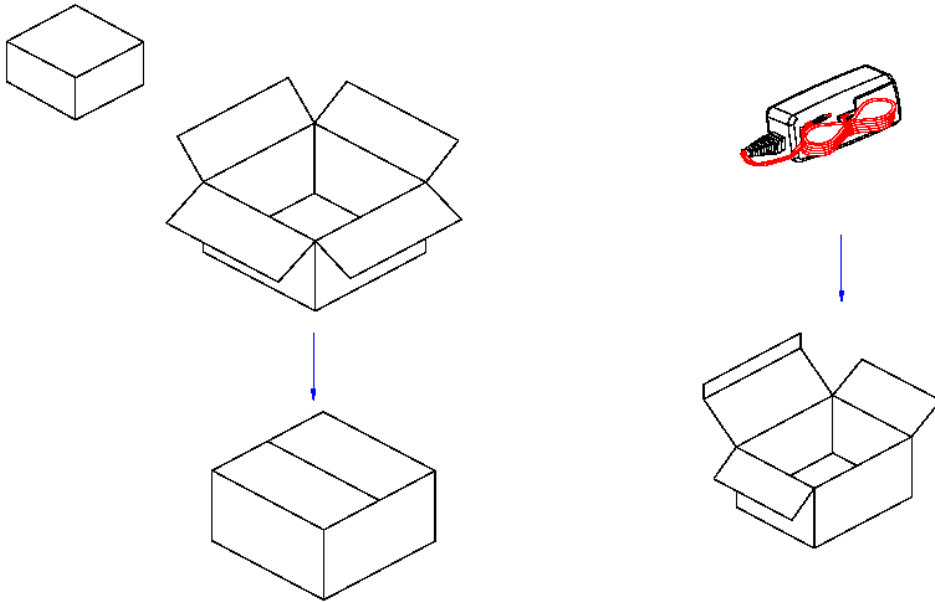
